JETS overview

JETS is a an online ePortfolio and certification portal for trainee endoscopists. It supports high quality endoscopy training in the UK by offering training courses for endoscopists and an ePortfolio for trainees to record their procedure data. The system has a framework for trainee certification in a number of endoscopy modalities including, but not limited to oesophago-gastro-duodenoscopy (OGD), colonoscopy, flexible sigmoidoscopy, endoscopic retrograde cholangio pancreatography (ERCP), and endoscopic ultrasound (EUS). Trainees can work towards certification in these modalities, by recording their procedure data.

The JETS ePortfolio is one of the most important methods for logging your endoscopic training and it is recommended you use this portfolio to record all your lists.

All gastroenterology and general surgery trainees at any level can use the ePortfolio and it has been developed to support them to meet curriculum requirements in endoscopy. Nurse, clinical endoscopists and GPs with a specialist interest in endoscopy can also use the system.

JAG certification is aimed at trainees and **not for those who are already independent endoscopists**. JAG certification is not a mandatory requirement and therefore not a requirement for any consultant post in the UK. For further information on this, contact the JAG team via our [webform](#).

Who should use this guide?

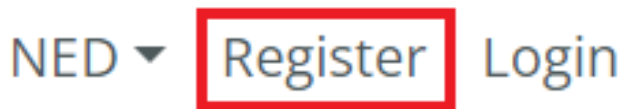

The page will ask you to provide your personal details, which includes your 'professional body.' If none of the options in the dropdown apply to you, select 'other.'

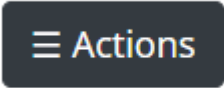

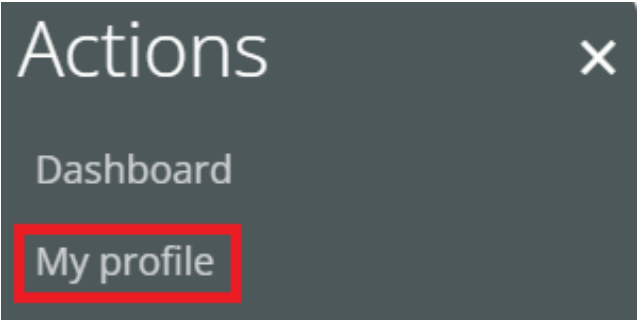

Once you have created an account, you can link your account to your organisation to get the most out of your account. You can do this by searching for your site name in the ‘work details’ section of your profile.

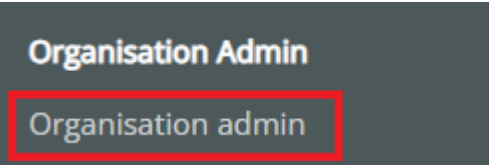

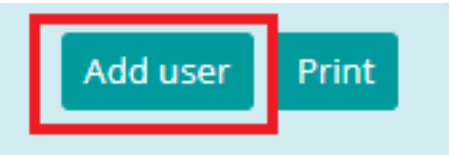
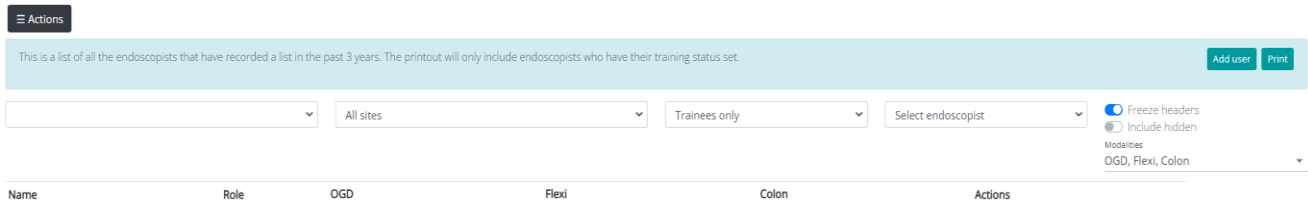
Please note – only services that are registered to the JAG programme will be able to search for their service (this does not currently include services in the Republic of Ireland).

Linking a user to your organisation

Training leads and centre administrators based at a service can link staff from their service to the organisation on the website. If you are a training lead or centre administrator, go to the ‘actions’ tab on the left-hand side of your screen and select ‘organisation admin.’

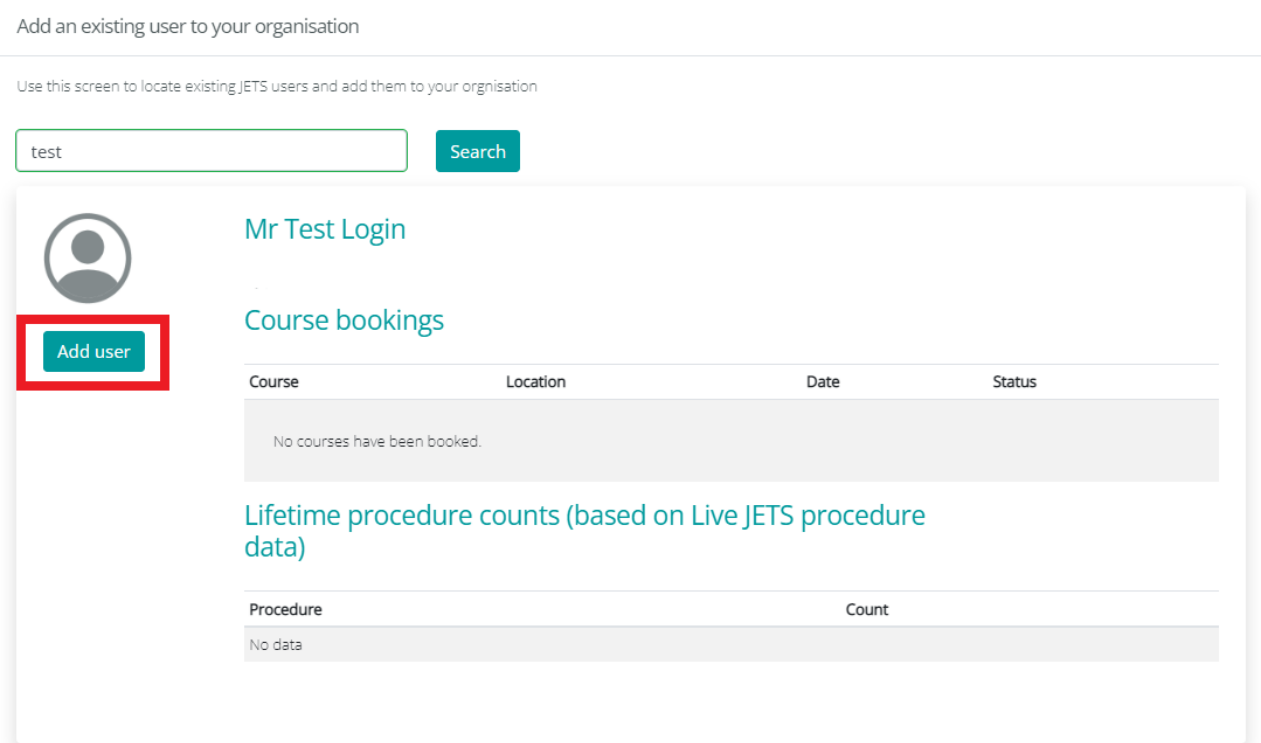


Once in the organisation admin page, an ‘add user’ button is available on the top right corner of the page.



Once you have selected ‘add user,’ a pop-up will appear that allows you to search for a specific user by name, registration number (such as GMC or NMC), or email address (we recommend searching for a person using the latter two options). The user must already have a JETS account.

Once the person appears, click on ‘add user’ button below, which allows you to add the user to your organisation.

After the user has been added, they will then appear in the list of users in the centre administrator and training lead's 'organisation admin' page. You can remove any user by selecting the 'remove' button.

Setting certification levels

After a user has been linked to their organisation admin page, their certification levels will need to be set. The website has the below levels and the training lead at the service will need to select the appropriate levels that need to be set for each individual.

Certification Level Descriptors	
Not set	Any individual not training in a modality, nor are they independent/training
Trainee	needs direct supervision at all times.
Full Certification	fully certified to perform this procedure but not training others. This can be set at a local level where JAG certification was not achieved prior to independent sign off.
Trainer	fully certified to perform this procedure, training others.
Trainer + TTT	fully certified to perform this procedure, training others and with prior skills training experience (eg attended TTT course).
TTT Trainer	fully certified to perform this procedure, training others and with prior skills training experience and faculty on TTT courses.

Selecting 'full certification', 'provisional certification' or 'trainee' will cause the endoscopist to appear as a trainee on the organisation admin page.

Roles on the JETS website

The JETS website allows staff within a service to have different levels of access on the site. This will depend on the role they have in the service. Below is a summary of the roles on the JETS website.

Endoscopist – this is the basic trainee role on JETS. This allows you access to your portfolio, to add procedures and gain certification. This role is standard for anyone that registers to JETS and has their service setup on the website.

Trainer – *set locally* – a trainer can sign off training lists, DOPS, and reflections for a trainee; and view their portfolio. They can also view their own feedback from trainees and other trainers.

Training Lead – the training lead can view and add all staff including trainees and trainers at the organisation. They can set certification levels for staff and can add someone as a trainer. They assign other training leads for their organisation and administrators. Training leads also sign off course bookings and certification applications.

Organisation admin – like the training lead, this role enables you to add or remove endoscopists, edit endoscopists certification levels or assign them as a trainer. This is a non-clinical role.

Deanery – this role allows you to view all trainees at your assigned deanery. You can view full portfolios including certification, and filter by organisation or site level views. If you require deanery access, please contact the JAG office via our [webform](#).

Each centre is responsible for assigning people to the above roles. If you encounter any difficulties with an account, please contact us via our [webform](#).

Adding procedures and lists

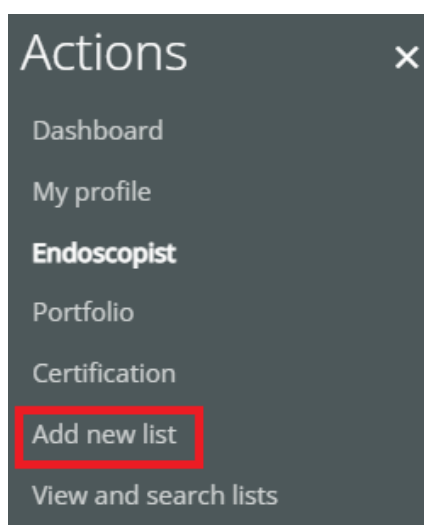
One of the key functions of the JETS website is the ability to add your procedure data on the site. Once you have access to the site, users can log procedures on JETS. These can be signed off (where needed), by a trainer based at their service.

There are three types of lists that can be recorded on the JETS website:

- **Ad hoc training list** – a trainer is required to sign off this procedure and a DOPS can be completed against the procedures in list.
- **Dedicated training list** – a trainer is required to sign off the procedure and a DOPS can be completed against procedures in list.
- **Service list** – no trainer is required and DOPS cannot be completed against procedures in this list.

If your site is uploading to NEDi2, your procedures should automatically upload from your endoscopy reporting system meaning there is no need for manual entry. If you are missing any automatic uploads, please check this locally before contacting the JAG office.

To manually add a list on the website, click on 'actions' and select 'add a new list' to record a list.



When you click on 'add new list,' a pop-up box will appear, where you need to add information about your list.

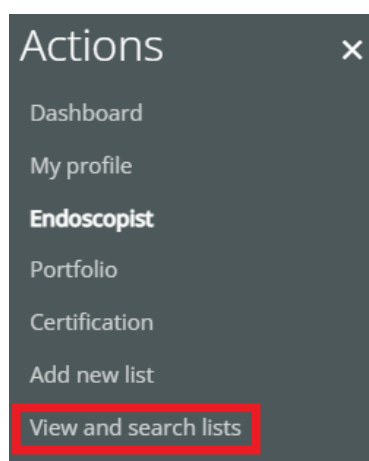

This enables you to record DOPS for the following modalities based on the previous data input:

- Formative DOPS: Diagnostic upper gastrointestinal endoscopy (OGD)
- Formative DOPS: Colonoscopy and Flexible Sigmoidoscopy
- Formative DOPS: Endoscopic retrograde Cholangiopancreatography (ERCP)
- Formative DOPS: Endoscopic ultrasound (EUS)
- Formative DOPS: Paediatric colonoscopy
- Formative DOPS: Paediatric Upper GI (OGD)
- Formative DOPS: Percutaneous endoscopic gastrostomy (PEG)
- Formative DOPS: Upper GI Bleeds
- Formative DOPS: Dilation/Stents
- Formative DOPyS: Colonoscopy and Flexible Sigmoidoscopy

The trainer must fill in the DOPS form with scores and comments. Your trainer must sign the form by entering their password in the sign off box at the bottom of the page. This can be done in person on your account or on your trainer's account. DOPS will only count towards certification once they have been signed off by your trainer.

If you are awaiting automatic upload of a list from NEDi2, but still want to add a DOPS, you can do this by clicking 'add new list'. Fill out the list details, and then select 'Add DOPS to list':

Ideally your DOPS should be added to a specific procedure, however if you are uploading procedures via NED and there is a delay in the upload you can add the list and add a DOPS to the list using the button above. Once the procedure has loaded via NED you can assign the DOPS to that procedure.

This will allow you to add a DOPS without adding a duplicate list to JETS.

How to view DOPS and DOPyS

If you want to view a completed DOPS or DOPyS form, you can do this by clicking into the list with the relevant form. You can then see the DOPS that have been added for each patient within the list.

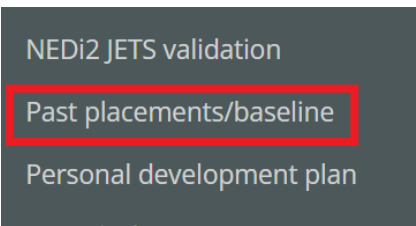

Uploading historical procedures

If you have accumulated procedures from a previous organisation, from overseas or prior to the JETS website's inception, the website has a facility which allows individuals to upload historical procedure data. This is added to the baseline section of the site.

Go into the 'actions' tab and click on 'past placements/baseline.'



Search for the unit through the 'select a service' search function. If the trainee was working abroad enter, 'non-UK.' Enter the date you worked at this organisation and click 'add.'

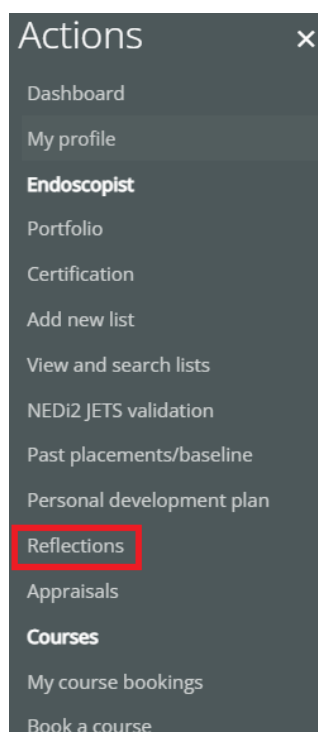
The data added at UK sites is counted in your lifetime procedure count, which will be reflected on the relevant certification page after addition.

Any procedures performed in a JAG accredited unit in the Republic of Ireland can be added to baseline procedures against the specific site where the procedures were done, these procedures will then count towards the lifetime procedure count. For other non-UK sites, procedures can be added to the baseline and candidates can apply for overseas exception. If approved, these procedures will be added to their lifetime procedure count.

For non-UK baseline additions, an 'Exceptions of overseas procedures on JETS portfolio' form must be completed by a trainee's training lead. Please contact us via our [webform](#) for information on accessing this form.

Adding reflections

Reflections will only become available after you have entered 50 procedures for your certification. The system will automatically generate a reflection and show it as an action on your dashboard. This will also be accessible in the 'actions' menu.



You can also access reflections through the portfolio page.

Please note, these reflections tabs will only appear once you have fulfilled the criteria to complete a reflection.

The reflection will display the KPI's for your previous 50 procedures and ask you to answer questions regarding the data and your progress.

Upon opening the reflection, you will see a brief overview of the 50 procedures, as shown below.

You can then select the 'reflection' tab at the top, where you will be able to answer two questions regarding the procedures, add a personal development plan and get your trainer to sign off the reflection.

Reflection bypass

Reflections will only generate on training procedures entered in a sequential order. This means once a reflection has been generated, any procedure entered before the date of reflection would not count to further reflections.

For example, if a reflection generates on 50 procedures from 1st September – 1st November, and then 5 procedures are added to JETS dated 30th September, these 5 procedures would not count towards your future reflections.

As a result, you may meet all criteria, including procedure count, without the full number of reflections being generated. In this case, only once all KPIs and other reflections have been completed, we can allow a bypass for remaining reflections. This should be agreed with your training lead before contacting us for the bypass to be added. Please contact us via our [web form](#) to request a reflection bypass.

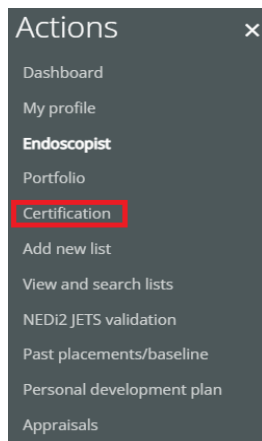
Certification pathways

How to view your certification data

The JETS website has a framework for trainee certification in a number of endoscopy modalities, including OGD, colonoscopy, flexible sigmoidoscopy, ERCP, and EUS . Trainees can work towards certification in these modalities, by recording their procedure data on the website.

To work towards accreditation in one or more of the JETS modalities, each individual will use the 'certification' page below to view their progress. This section of the site allows you to review the JAG certification criteria for accreditation and view your progress against the modalities.

You can view your certification data in the 'certification' tab in the actions menu:



The certification dashboard, seen below, allows you to navigate between the different modalities and view your key performance indicator (KPIs) data for each pathway.

Certification dashboard

Please note: Your data is refreshed every evening, your newly added procedures will not reflect in your portfolio or certification pathway until it has been refreshed. Last refresh was 9 hours ago.

JAG Certification supports trainees through a training pathway. If you are an established endoscopist you are not eligible to apply for certification.

When a trainee successfully applies for colonoscopy (new pathway), they will obtain a waiver for flexible sigmoidoscopy certification with no extra fee.

Once a trainee is meeting all the KPI's they are required to submit summative DOPS before they can proceed to the next stage.

Completing summative DOPS

Summative DOPS (direct observation of procedural skills) are forms completed at the final stage of the certification pathway. They are observed procedures that are used as certification criteria. After you have hit all the key performance indicators for the relevant certification pathway, you will be able to progress your application to the summative DOPS stage by clicking the 'start application' button on your certification page.

Once a candidate clicks 'start application' to begin their summative DOPS stage, the candidate's key performance indicators will be frozen.

Summative DOPS criteria

Summative DOPS can be carried out in any combination of ways that fulfil the following criteria. For summative DOPS the following conditions apply:

- Minimum of 2 assessors
- Minimum of 2 cases
- Minimum of 4 DOPS
- All must be completed within a month
- No assessor is the current primary endoscopic trainer

Here is an example of how the summative DOPS can be completed:

- 2 x 2 process simultaneously – 2 assessors over 2 cases
- 2 x 2 process sequentially – 2 assessors over 4 cases
- 2 x 1 x 1 process – 3 assessors over 4 cases
- 1 x 1 x 1 x 1 process – 4 assessors over 4 cases

The box next to each item in the DOPS form is marked for competency. Each item needs to have a corresponding 'not competent for independent practice' or 'competent for independent practice' filled in for the DOPS to be complete. Comments can be added next to each section.

Once you have completed the required summative DOPS, send them to the assessor who observed the procedure by clicking 'save' at the bottom of the DOPS. Alternatively, if you are with the assessor while completing the summative DOPS they should be able to sign off the form from the trainee's account by inputting their password and clicking 'sign off.'

Completing summative DOPS – common issues.

Issues selecting a trainer

If you cannot select a trainer from the dropdown when completing your summative DOPS, this is likely due to the following reasons:

- Your trainer's JETS account may be inactive; in this instance, the trainer should contact the JETS team to activate their account to gain access.

- Your certification/training levels might not be set correctly. To correct this issue, you will need to contact your training lead or organisation admin so that they can set your training levels. Please see 'setting certification levels' in this guide for more details on how to do this. When your training levels have been set correctly, you should be able to select a trainer.
- Your account needs to be linked to your organisation. In this instance, also contact the training lead or organisation admin at your service to add you to the organisation.

View the training lead and organisation admin access section of this guide to learn more about how to amend certification levels for staff.

Submitting certification

Once a trainee has met the criteria to be signed off for certification, they will be required to send the application onto the training lead at their organisation to get signed off. (This will only be allowed once the KPI's have been met.)

Signing off certification as a training lead

Completing course feedback

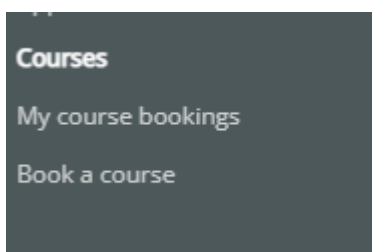
Once you have completed the faculty feedback form, it is important you select 'sign off' and not just save it. If you don't select 'sign off', your certificate will not be generated.

Completing all faculty feedback and course feedback will then automatically generate your certificate, go to 'my course bookings' under the actions bar.

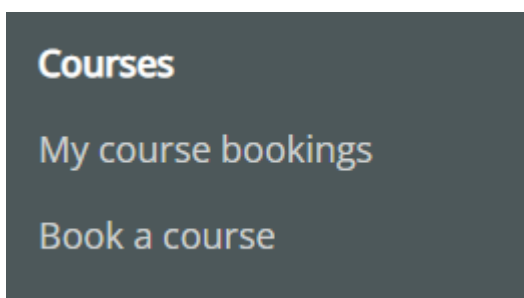

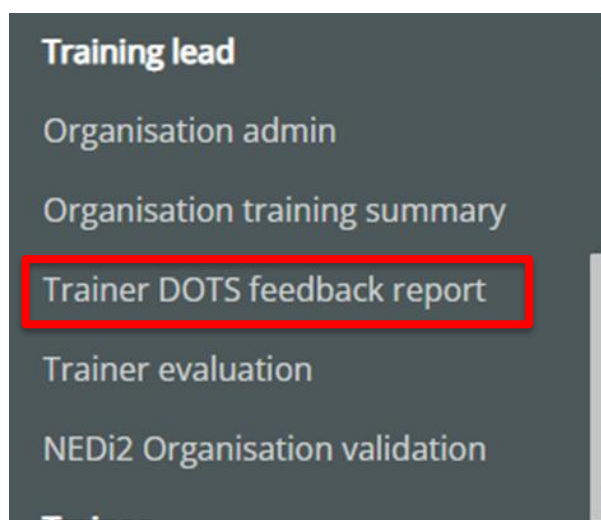
Extracting DOTS feedback

Direct Observation of Training Skills (DOTS) enable trainers to complete assessments on fellow trainers. This will allow users to evaluate the training skills of their peers.

The ‘training feedback’ is a record of feedback left for trainees.

Also, trainees can provide feedback to trainers at their service after a procedure. Feedback is submitted by trainees and trainers through Direct Observation of Training Skills (DOTS) forms.

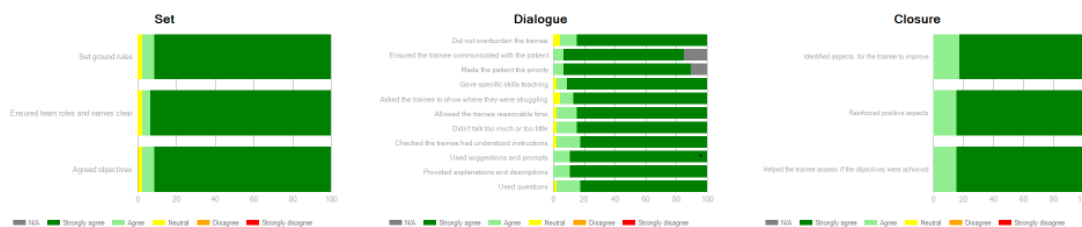
Training leads and trainers can access DOTS for trainers in their organisation by selecting ‘trainer DOTS feedback report’ from the ‘actions’ menu.



The next page will generate bar charts and a few dropdowns will appear at the top which will allow you to amend the details to generate the information you need. Depending on the information you require, for instance if you are seeking the feedback for a certain trainer, select their name under ‘trainer’. Add the timeframe and select ‘filter’ on the right-hand side.

Personal development plan (PDP)

Personal development plans enable trainees to create an action plan based on reflection, goal setting and planning for personal development with set deadlines. Any user set up as an endoscopist has PDP access.

This is where you can keep a log of your PDF. Your log can be extracted to a MS word document for personal use. Any objectives that are logged in procedure lists will automatically populate in this section. You can add objectives by clicking the 'Add new PDP' button at the top or bottom of the page.

Procedures on NED
